IMPORTANT INSTRUCTIONS ON DOCUMENT VERIFICATIONS OF COMBINED
GRADUATE LEVEL-2017

1. OBC certificate must have mention of Govt. of India Resolution No. by which the caste of the candidates is included in the Central List of OBC. For the purpose of Non-Creamy Layer Status. The OBC candidates Must ensure that he/she does not fall in creamy-Layer on 16.06.2017. In case, the competent authority of issuing OBC certificate is below the rank of Tehsildar, then a certificate from the concerned District Administration regarding delegation of such power to the issuing authority is required to be furnished.
2. The candidature of those candidates will be cancelled by the Commission who fail to produce the relevant certificate such as Mark Sheets & Board Certificate of X Class, XII Class and Graduate Degree in original as proof of having acquired to minimum educational certificate on or before 01.08.2017 as per **para 6** of the notice of examination The candidates who are able to prove by documentary evidence such as certificate issued by the concerned Competent Authority of the Board/Institute/University that the result of the qualifying examination was declared on or before the cut-of date and he/she has been declared passed, will also be concerned to meet the Education Qualification.
3. For verification of Date of Birth, candidates are required to furnish 10th class Board Certificate only.
4. For claim of age-relaxation in upper age limit of age criteria, the appropriate certificate issued from the competent authority is required to be furnished
5. SC/ST category candidates must submit their caste certificate in support of their claim in the prescribed performa as per annexure-VI of notice of examination.
6. (i) A Matriculate Ex-Serviceman (which includes an Ex-Serviceman, who has obtained the Indian Army Special Certificate of education or corresponding certificate in the Navy or the Air Force), who has put in not less than 15 years of service as on **16.06.2017** with Armed Forces of the Union shall be considered eligible for appointment to the Group 'C' posts being advertised through this examination. Thus, those Non-Graduate Ex-Servicemen who have not completed 15 years of service as on the closing date for receipt of application (**i.e.16.06.2017**) or would not complete 15 years of service within the time limit specified in para 5 (F) are not eligible to apply for this examination.

(ii) Ex-servicemen who have already secured employment in civil side under Central Government in Group 'C' & 'D' posts on regular basis after availing of the benefits of reservation given to ex-servicemen for their re-employment are NOT eligible for fee concession. However, he/she can avail of the benefit of reservation as ex-serviceman for subsequent employment if he/she immediately, after joining civil employment, gives self declaration/undertaking to the concerned employer about the date-wise details of application for various vacancies for which he/she had applied for before joining the initial civil employment as mentioned in the OM NO. 36034/1/2014-Estt (Res) dated 14.08.2014 issued by DOP&T.

Thus the Ex-Serviceman candidates who are already in Civil Employment are eligible for age relaxation benefits only if they fail to produce a copy of the declaration submitted to their concerned Department at the time of their Joining that they have also applied for the said exam.

(iii) Age concession is not admissible to sons, daughters and dependents of Ex- Servicemen.
