RESULT

On the basis of Recruitment Test for the posts of 'A' Class Naib Tehsildar (Apprentices) Gazetted Class-II (Group-'B') in Revenue and Disaster Management Department, Haryana conducted by the Haryana Public Service Commission on 26.05.2019, the candidates, three times the number of vacancies along with bracketed candidates, if any, bearing the following Roll Nos. have been declared qualified for Viva-Voce provisionally, subject to the fulfillment of all eligibility conditions. It is also made clear that mere being declared successful in this examination, the candidates will not be entitled for any right for the said posts. - 4. Where no post for any reserved category is available, the candidates applying as a candidates of that particular category have been considered as General Category candidates subject to the fulfillment of all the eligibility conditions (except fees) as meant for General Category candidates.
