- 02 SC/ST and PwBD (Persons with Benchmark Disabilities) candidates with 50% marks in qualifying examination are eligible to apply.
- 03 The upper age limit is relaxable by 5 years for SC/ST, 3 years for OBC (Non-creamy layer). It is relaxable by 10 years for PwBD - General, 13 years for PwBD - OBC and 15 vears for PwBD - SC/ST candidates.
- 04 The upper age limit is relaxed by 5 years for the candidates who had ordinarily been domiciled in the State of Jammu & Kashmir during 01.01.1980 to 31.12.1989.
- 05 The relaxation of age for Ex-servicemen shall be as per Government guidelines.
