CORRIGENDUM

Subject:- Recruitment under Phase-XIII/2025/Selection Posts Examination.

Candidates may refer to the Notice of Phase XIII/2025/Selection Posts Examination uploaded on the website of Staff Selection Commission on 02.06.2025. The following modifications / corrections have been made therein:-

(i) The vacancies of **Post Codes No. NE10725 and MP11325** for the post of **Staff Car Driver (Ordinary Grade)** in Enforcement Directorate have been accounted for under 26 vacancies notified through Post Code No. **NR14725**.

(ii) The vacancies of **Post Code No. NE10525** for the post of **Workshop Attendant** in National Career Service Center for Differently Abled have been accounted for under 16 vacancies notified through Post Code No. **NW11125**.

2. Since the vacancies notified under **Post Code Nos.: NE10725, MP11325 and NE10525** are the duplicate entries, these post codes have been deactivated from online application system and it will no longer be functional. **Hence, the Post Code Nos. NE10725, MP11325 & NE10525 stand deleted from the list of vacancies (Annexure-III of the Notice).**

3. The candidates, who have already **submitted online application** against **Post Code Nos. NE10725, MP11325 & NE10525**, **need not apply again** against the Post Code Nos. **NR14725 and NW11125**. Their applications will be **considered automatically** against the vacancies notified for **Post Code: NR14725 (Staff Car Driver - Ordinary Grade) and NW11125 (Workshop Attendant)**, as the case may be. All such candidates are advised to visit the website of the Commission periodically for further updates.

4. Further, the provisions stipulated at **Para - 7.7 [Special Instructions for Ex-Servicemen (ESM) Applicants]** of the Notice are also modified as under:-

For any serviceman of the three Armed Forces of the Union to be treated as ESM for the purpose of securing the benefits of reservation etc, he/she must have already acquired, at the relevant time of submitting his/her application for Post/ Service, the status of ESM; or is in a position to establish his/her acquired entitlement by documentary evidence from Competent Authority that he/she would complete specified term of engagement with the Armed Forces within the stipulated period of one year from 01.08.2025 . Such candidates must also acquire the status of an ex-serviceman within the stipulated period of one year from 01.08.2025 .	For any serviceman of the three Armed Forces of the Union to be treated as ESM for the purpose of securing the benefits of reservation etc, he/she must have already acquired, at the relevant time of submitting his/her application for Post/ Service, the status of ESM; or is in a position to establish his/her acquired entitlement by documentary evidence from Competent Authority that he/she would complete specified term of engagement with the Armed Forces within the stipulated period of one year from the closing date of receipt of application . Such candidates must also acquire the status of an Ex-Serviceman within the stipulated period of one year from the closing date of receipt of applications .

5. Other provisions and conditions stipulated in the Notice of Phase-XIII/ 2025/Selection Posts as published on **02.06.2025** will remain unchanged.
